## Summer Camp Policies *(updated 2/5/19)*

*For Teen Adventure Camp, Vacation Fun Camp and Summer Day Camp*

**The safety and health of all campers is our #1 priority!** Please read the following policies. When you sign the PARTICIPANT RELEASE WAIVER on your registration forms, you are acknowledging that you have received, understand and accept the policies below.

### ILLNESS

You do not need to call if your child will be home sick from camp. You DO however, need to be sure that they are free from all symptoms prior to returning to camp. If your child is experiencing vomiting, a fever or diarrhea they must wait 24 hours AFTER symptoms subside before returning to camp.

If your child catches any highly contagious disease such as conjunctivitis or strep, we will need a doctor's note that they have been on medication for at least 24 hours prior to returning to camp.

### DISCIPLINE

When the situation justifies, your child will be sent home with a discipline slip(s). In one eight-hour day, it is possible for your child to receive more than one slip. The slip(s) must be signed by a parent/legal guardian and **returned the very next day** the child attends camp. **Your child will not be admitted back in camp without the signed slip(s).** Should your child receive three (3) slips, the child will be removed from camp with no refund issued. Again, the safety and welfare of ALL camp participants is our priority.

### PAYMENT

Payment for all camps should be paid in full no later than June 21, 2019 unless other arrangements have been made and approved in writing by the director. Early payment plans are available beginning February 11, 2019 to allow time for you to fit camp into your budget! Bathing suit/towel
